- The Government of the United Republic of Tanzania has applied for financing from the World Bank towards the cost of the Development Corridors Transport Project (DCTP) and intends to apply a portion of the proceeds for Consultancy Services for Design Review and Supervision of Rehabilitation of Lusahunga – Rusumo Road (92 km).
- 2. The Project is located in Kagera Region. The Lusahunga Rusumo Road (92 km) forms part of T3 (Central Corridor Highway), which connects the Dar es Salaam Port with the land locked neighboring countries of Rwanda and Burundi. The consulting services ("the Services") include design review and supervision of construction of the Works for rehabilitation of Lusahunga Rusumo road, for a period of twenty-four (24) calendar-months and twelve (12) months for the Defect Liability Period. Within this context, the Consultant shall be entrusted with the following responsibilities as described in the Terms of References (TOR) for the Assignment:
 - (a) Carrying out design review and supervision of civil works and ensure compliance with the approved design, drawings, specifications, conditions of contract, approved works programmes and sound engineering practice;
 - (b) Prepare comprehensive reports in each month on the Environmental and Social Management Plans (ESMP) and provide annual reports on measures adopted for the safety of the Project roads, sensitization of local population on HIV/AIDS, STI, TB and Gender
 - (c) Review of the proposed traffic deviations during construction period for the purpose of ensuring that the proposed traffic arrangement results minimal disruption to the public;
 - (d) Preparation of the Final Completion Report (FCR) and "as-built-drawings" for all completed civil works along the Project Corridor; and.
 - (e) Carry out supervision of activities during the Defects Notification Period.
- 3. Tanzania National Roads Agency (TANROADS), an Executive Agency of the Ministry of Works, Transport and Communication now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The shortlisting criteria are: eligibility, experience on similar assignments in the last ten (10) years, experience of undertaking assignments under similar conditions and availability of appropriate skills among staff in relation to the assignment in context.
- 4. The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank's Guidelines: Selection and Employment of Consultants under IBRD Loans and IDA Credits & Grants by World Bank Borrowers, January 2011, revised July 2014 ("Consultant Guidelines"), setting forth the World Bank's policy on Conflict of Interest.
- 5. Consultants may associate with other firms in the form of a Joint Venture or a Sub-consultancy to enhance their qualifications.
- A Consultant will be selected in accordance with the Quality and Cost Based Selection (QCBS) method set out in the Consultant Guidelines.
